

Research Participation Agreement

I, (*PRINT NAME*), enter into this agreement ("Agreement") so that I may provide feedback, statements, comments, suggestions, and ideas ("Ideas") to Uber regarding its products and/or services ("User Research"). As explained below, this agreement requires me to treat information shared during User Research as confidential, and assigns to Uber Technologies, Inc. ("Uber") ownership of all Ideas I provide with no further compensation to me. My participation in this User Research is voluntary. I agree that I have received good and valuable consideration in exchange for my participation in this User Research, including, without limitation, the opportunity to provide Ideas to Uber. I understand that Uber may collect personally identifiable information from me which will be treated in accordance to Uber's Privacy Policy, available at <https://privacy.uber.com/policy>. To the extent I provide Ideas to any of Uber's designated third-party agents, I understand they may also collect personally identifiable information from me which may be subject to certain terms and conditions. This Agreement supplements but does not supersede the dscout Scout Terms and the dscout Privacy Policy, both available at dscout.com/legal, to which I have previously agreed and remain subject.

1. Confidentiality: During the User Research, I acknowledge that I may receive certain information that is non-public and previously unknown to me ("Confidential Information"). I agree that I will: (a) maintain all Confidential Information in strict confidence and not disclose Confidential Information to anyone; and (b) not use Confidential Information for any purpose except as may be authorized by Uber in writing. All Confidential Information remains the sole and exclusive property of Uber. I agree that nothing in this Agreement will be construed as granting me any rights, by license or otherwise, in or to any Confidential Information or any intellectual property or proprietary rights of Uber. On termination of this Agreement, I agree to return all records, notes, drawings, or other documents of any sort, including any copies, that contain Confidential Information. The obligations set forth in this Section 1 (Confidentiality) shall survive for 5 years from the date of last disclosure of Confidential Information hereunder.
1. Submission/Recordings: I understand and agree that I may be voluntarily providing (whether orally or in writing) Uber and/or its designated agents with Ideas and that my participation in the User Research may be recorded via audio and/or videotape ("Recordings"). Uber is not obligated (and makes no commitment) to treat or maintain any Ideas I submit as confidential. Uber will own, and I hereby assign to Uber, all right, title, and interest in and to the Ideas [and Recordings], including any intellectual property in, arising from or relating to the Ideas [and Recordings], with no further compensation to me.
1. General: I acknowledge that the unauthorized use or disclosure of any Confidential Information would cause Uber irreparable harm and significant damages that are difficult to measure. Accordingly, I agree that Uber will have the right to obtain immediate equitable relief to enjoin any unauthorized use or disclosure of its Confidential Information, in addition to any other rights or remedies that it may have at law or otherwise. **In no event will Uber's total cumulative liability to me in connection with User Research exceed \$500.** This Agreement will be governed by the laws of the State of California (excluding its body of law controlling conflicts of law). I may not assign or transfer this Agreement, in whole or in part, without Uber's prior written consent. Any modification of this Agreement must be in writing and signed by Uber. If any provision of this Agreement is invalid or incapable of enforcement for any reason, all other provisions shall remain in full force and effect. This Agreement is the complete and exclusive statement regarding the subject matter of this Agreement and supersedes all prior agreements and communications, oral or written, between the parties regarding the subject matter of this Agreement.
